# **Bridge Garage**

The council have received many complaints about the deteriorating condition of the Bridge Garage and former Antiques Emporium in London Road. We have asked Wiltshire Council to take enforcement action against the owners to improve this key site on the approach into Marlborough from the east.

Part of the site is a grade II listed building which places a duty on the owner to maintain the building as an important historic asset. We were also concerned to learn that part of the buildings were being used as a residence, and that following a visit from the Housing Officers, that part was condemned as being unfit for habitation, and the tenant was forced to move out.

Wiltshire Council have agreed to approach the owner with a view to them carrying out essential repairs and maintenance. It is in the owners interest that the building does not fall into rack and ruin. We shall be monitoring the situation for improvements.

#### Town Council by-election

A by-election will be held in the Marlborough West ward on 13 October 2011 to fill the vacancy that resulted from the resignation of Cllr Martin Houlden. The polling
