# **PUBLIC QUESTION TIME**

Ruth Bordiss - will the Town Council support the residents of Stoneking Court and Salisbury Road in relation to the tree works that have been carried out at the Bridge Garage site.

The Mayor - replied that the Town Council had formerly requested that the Enforcement Team at Wiltshire Council investigate a possible breach of planning conditions relating to Application 17/00937/TCA for tree works in a conservation area. (Minute No. 541/17 refers.)

The Town Clerk - confirmed that this action highlighted that the Town Council shared residents' concerns about the actions taken and the issue would be added to the next Planning Committee agenda.

**The Mayor –** stated that she was disappointed with the lack of police presence in Marlborough and felt that this has led to an increase in anti-social behaviour.

The Town Clerk - informed Members that there would be an increase in police patrols at Priory Gardens. Members felt that it would be a good idea to invite Angus Macpherson, the Police and Crime Commissioner, to a Full Council meeting to discuss local policing issues.

**Clir Castle –** reported that the abandoned vehicle in Kennet Place had been served with a notice and should be removed by the end of the week.

**Clir Dobson** – reported that he has helped to secure the site for the Rotary Christmas Tree for this year only. It would be in one of the disabled bays in the High Street, but an alternative would need to be found for future years.

The Town Clerk on behalf of Cllr Fogg – reported that he would like consideration to be given to CCTV coverage for Kingsbury Street due to incidents in this area. This would be added to the agenda for the next Full Council meeting.
