



CCTV



It's not an easy decision with costs, requirements around the Protection of Freedoms and Data Protection laws and the actual levels of crime all having to be taken into consideration. Initial estimated costs are likely to be in the region of £25,000 - £35,000. Alongside installation, there will also be ongoing maintenance costs. The Town Council has already ring-fenced £20,000 towards this through savings and is working alongside the Chamber of Commerce to identify external funds. We are now looking at proposals from suppliers.

Prior to signing any contract, we feel that it's important to have your views on the overall principle of having CCTV in the town. There is also an opportunity for you to leave comments.

CCTV

1. Summary

At the Full Town Council meeting of 4th November 2013, Town Councillors decided to undertake a consultation around the issue of CCTV in Marlborough. Over the last few years, CCTV has been debated and residents have been invited to express opinion through public meetings and unofficial straw polls. There has been no wide public consultation exercise by the Town Council about CCTV. It has also been prompted by the new Surveillance Code of Practice which urges local authorities to consult

The consultation's aim was to find out if local people supported the Council's decision to install CCTV in Marlborough. As well as this question, all participants were asked to include their postcode and invited to add comments.

2. Methodology

At the meeting on 4th November, wording to the draft consultation was amended and agreed. The survey was posted online on 8th November on the Town Council website at www.marlboroughtowncouncil.gov.uk. Links were posted on the Council's Facebook page, St John's website and Sparksite. The consultation was also included in the December edition of *Marlborough – Town and Country* and paper copies were available at the Library and Town Council offices. Posters were displayed on notice boards throughout the town. It was also promoted via Marlborough News Online and in editorial in the Gazette and Herald.


3. Consultation Feedback - The Stats

The consultation ran from 8th November – 20th December 2013 (6 weeks). A total of **456** responses were received. Of these, **293 (64%) were in favour** and **163 (36%) against**. The outcome is broken down as follows:






4. Further Breakdown


These overall results can be broken down further using postcodes. This way it can be seen how many responses were from Marlborough and from outside the parish. It is difficult to judge the demographics of those responding from outside the parish but they are likely to include pupils and parents at St John's and those people working in the town. The statistics for Marlborough have also been broken down into Wards - East and West. A total of 28 responses did not show a postcode (6% of all responses).






5. Observations


It is interesting to note that the response from both East and West Wards are very similar and shows that, together, the response from Marlborough is 63% in favour and 37% against (reflecting the overall result). Also, that those responding from outside of the parish voted overwhelmingly in favour of the decision to install CCTV (72% for and 28% against). The demographic of this group is not clear but, it is likely that they are parents and pupils from St John's, people who work in the town and those living in the surrounding area using the town as their service centre or tourists.

6. Additional Comment

Not all respondents left additional comments but where they did, most fell into broad themes. These were:

Other comments included suggestions for sites, experiences of crime in the town, requests that a contribution should be made by the business community and more detail of cost. Also, that any system should be of high quality, that CCTV is no replacement for visible policing, that it will help improve the feeling of safety, it would help to provide evidence towards prosecution. A full list is at **Appendix 1**.

7. Conclusion

The statistics show that most feedback (64%) supports the Town Council's decision to install a CCTV system in Marlborough. The majority of comment shows that those supporting CCTV see it as a deterrent, which will give an increased feeling of safety and with many feeling that a system should have been in place some time ago. Those against CCTV (36%) see it as costly and a waste of public funds, an intrusion of privacy and that there is insufficient evidence to show that it will reduce crime rates.

Safety has to be no.1!

There are other ways of keeping streets safe.

Retailers should pay not the residents.

Expensive for little or no return.

If the Council has spare funds, they should use them to reduce the Council Tax.

The rich shop owners could pay for their own CCTV.

It is my money being wasted to make the posh shops feel better. How much are they investing to make me feel secure?

I think it unnecessary and would prefer the money to be used for young teenager, e.g. bus travel.

A criminal waste of money, has no one read Nick Fogg's report.

I strongly object to this proposal as a waste of public money. The low crime levels in Marlborough do not require CCTV for public protection and I object to being spied on whilst going about my business in the town.

I have seen no compelling evidence that it serves to reduce crime. There are parts of the country which are

bristling with cameras where levels of crime still remain relatively high, and in Marlborough, which has had no CCTV, crime has remained relatively low.

CCTV is not going to prevent anything when the majority of the time most policing is done from outside the town.

Crime levels in Marlborough are already very low; we live in one of the safest places in the country. There is no evidence that CCTV has any effect on anti-social behaviour. Aside from that, I do not wish to have to pay for initial or ongoing costs of CCTV.

CCTV will not answer the policing "problems" of Marlborough. Crime ion this town is low. Anti social behaviour needs bobbies on the beat, sanctions against those who sell alcohol and an understanding of this societies overall problems. Businesses can pay fro CCTV.

This is a complete waste of public funds. I have lived in many towns and Marlborough is certainly at the top of the safety scale. We need to spend money on dealing with social issues.

There is no need for CCTV in the High Street. The prompt action from other shop-keepers and members of the public during the recent break in of the jewellers shop shows that we are a cohesive community. If shop-keepers want CCTV they should pay for it themselves.

Having listened to many arguments, for and against the installation of CCTV in our small rural market town, with its minute crime rates, I feel the basically very low level of crime preventable or prosecutable means this is a waste of money and resources.

Not needed, low crime rate, too expensive waste of money.

I feel that this is a waste of money. No end of studies is out there showing that CCTV has a negligible effect in pretty much every crime area except that in car parks. A camera cannot chase down and arrest a wrong-doer or intervene to prevent a mugging.

An unproven deterrent

I am against CCTV as it is a costly and ineffective deterrent to crime. But this consultation does not present residents with the full facts to make a decision. I Instead you have presented a biased and misleading case for people to respond to.

Just unbelievable, can we no more go on with our daily lives in our very own hometown without being surveyed, judged and victimised as a result of an unnecessary invested that will commercialise this towns authenticity?

DEFIANTLY NOT. A complete invasion of privacy!! Marlborough is a place to be proud of the fact,

that even walking through the High Street you are NOT being constantly tracked/filmed by CCTV, and thinking it's alright to spend over 25K on it, what a joke.

Myself and many others I've spoken to feel that Marlborough is a perfectly safe place to live, no one I know has come into contact with anti social behaviour and we've lived in and around the town all our lives.

Reasons for NOT having CCTV 1) USP for the town is not having CCTV 2) If shops feel they need it they should pay for their own security. 3) The crime figures are do not show any difference between those places that have than those that do

THIS IS STUPID! A WASTE OF MONEY! Try thinking of a better way of using this available money, say public transport, homeless individuals or even just making Marlborough a better place to live.

I would rather see a traditional foot (or horse) police patrol on the high street which is more in keeping with the ambience, style and history of the town. It is not clear whether this move to CCTV is also aimed at monitoring parking in the town.

Where is the evidence that shows CCTV cameras reduce crime and anti social behaviour?

Not changing my view until we know the running and depreciation costs of this system, and how much the Chamber of Commerce is prepared to contribute.

Shopkeepers want it so they should pay for it not the Town Council who will no doubt increase the precept even more. In view of the £30,00 predicted shortfall in income 2014 financial year the precept increase could be considerable.

I believe CCTV is not the answer, the Deacons robbery took place in broad daylight with many witnesses, CCTV would not have prevented that. The Mayor's chain, not sure if CCTV would have stopped that. CCTV lots of money, could be spent on more visible policing.

Marlborough continues to be one of the safest places in England. Therefore this expenditure is unnecessary and monies, could be better spent on the young in the town.

Those businesses that would really benefit from CCTV can or already do have their own systems. A public system would be an expensive way of interfering with the day to day privacy of Marlborough's citizens and visitors.

Surely this consultation should have preceded the decision. I think it is a terrible waste of money to have CCTV. We are all responsible for our own security why should the shop keepers be treated differently.

We have enough intrusions into our daily life already.

There is no clear evidence from various research findings that CCTV reduces crime. Crime may merely be displaced from the city and in any case the initial impact lessens over time. Positioning is critical.

Waste of money, concentrate on more social housing....or is that too common??????

The street crime rate does not justify a system like this, which has become simply a political football for local politicians to score points. CCTV will be an ugly addition to wherever it is placed and introduced big brother policing to our town.

Does the cost of breakage and crime that could sensibly be stopped in the areas CCTV will be placed annually exceed that estimated to install and manage the CCTV system pro rata over its lifetime?

How can you make a decision based on feelings and not facts? I think you will find if you were to speak to an insurance company Marlborough has one of the lowest crime figures in Wiltshire. I've owned shops in town for 9 years

This is going to be a white elephant.

Does not stop crime, money better spent on toilets, tourist centre, kids facilities etc.

Absolute waste of money, think what 55k plus could be used for in terms of benefitting the town rather than what i can only understand as an invasion of privacy thinly veiled as a response to incredibly overstated crime and anti-social behaviour levels.

This is a very safe town and I personally don't think CCTV would have stopped the recent thefts.

Not keen on BIG Brother

I don't consider CCTV an effective deterrent and therefore not good value for money as a way of

combating crime. What about the ongoing costs? We have too much surveillance of our lives and it's a pleasure to know that Marlborough is a CCTV free zone.

There are better things to spend money on in Marlborough - part of the charm of living here is that, unlike other towns, your every move isn't watched. It should be down to the individual stores to install CCTV if they require it.

Waste of money!

This is a waste of our money; the money should be spent on providing better facilities for our people. We do not have a crime rate that justifies this expense. CCTV is used a sop to our citizens to make them feel safer.

The commercial community should bear the cost of CCTV as it is their property it will protect. Residents should not bear any cost as CCTV in the commercial area will not protect surrounding residential property.

The cost of CCTV should be borne solely by the commercial community as they are insisting on it to protect their property. The residents would not gain any protection from CCTV and it would not prevent car vandalism in St. Martins for instance.

We already have quite enough surveillance.

Does the level of crime really warrant such an expensive and intrusive measure? It is in most pubs and shops anyway.

CCTV is an intrusion to privacy and won't actually prevent crime. Appropriate policing would be much better.

Anti social behaviour and crime is minimal - I object to a further loss of privacy - one of the lovely things about Marlborough is how welcoming it is. CCTV will certainly send out the wrong message.

I think Marlborough is already a safe place to live. I believe CCTV to be an over-reaction to a very occasional problem and resent the intrusion implied by the system.

I hate the idea of being watched 24/7, but also understand the benefit of recording any crimes but would prefer if Marlborough could stay CCTV free.

I don't believe it should be down to the residents of Marlborough to pay for CCTV when shops (and in particular the jewellers) have the most to benefit.

Completely unnecessary and expensive. Also a massive intrusion into normal residents lives.

Incidents of crime in Marlborough are thankfully rare. I see no need for the expenditure or intrusion on our lives.

Let's resist the inevitable spread of surveillance, which infringes our rights to move around freely. We must not submit to paranoia and defensiveness.

Unclear problem, unclear benefits Unclear overall cost.

Waste of money, displaces crime and doesn't stop it. If the council has money to burn spend it on real police officers.

I can hardly believe you're considering this. People in this country, including people in Marlborough are having to choose between heating and eating and you really think this is where your attention and focus should be?

How can you justify spending that sort of money on a system which is an invasion of privacy and tantamount to spying. I would rather see the money spent on things which BENEFIT people and increase peoples wellbeing:

A lot of expense for little gain as far as I can see. Need a lot more information that showed the need and benefits before I would be able to say yes to this proposal

We are the most watched country in the world and I do NOT support the introduction of CCTV in Marlborough.

Marlborough is a busy thriving town, there are lots of witnesses buzzing around town should any crime happen.

I don't think the council has established a clear need and doesn't have a robust method for measuring the

results.

With talk of a substantial increase in the town precept next year this seems an odd time to be adding additional expense to the budget. Rates of crime in Marlborough are mercifully low.

Far too expensive and unnecessary in Marlborough.

It is an unnecessary invasion of privacy in a Town with a very low crime rate.

It is an expensive project which, as I understand it, is unlikely to have a significant impact on crime rates. While CCTV might make people feel safer, I'm not convinced it makes a difference to actual crime rates.

Many studies (Home Office and Academic) show that CCTV systems are not necessarily efficient in their overall impact on the incidence of crime. CCTV systems are complex to set up and expensive to run, maintain and update.

How can this be a valid public input to the decision making process when the Council has already taken the decision to proceed with the surveillance system?
