64/90 PROPOSED DIVERSION OF FOOTPATH NO. 39 MARLBOROUGH PROPOSED DIVERSION OF Un-NUMBERED PATH, MARLBOROUGH

COUNCILLOR M. P. COOPER DECLARED PECUNIARY INTEREST

Discussion took place on the letter received from the Wiltshire County Council giving details of the proposed diversion of the above paths as shown on the accompanying plan.

Councillor Perryman objected to the proposed diversion and together with Councillor Mrs. L. M. Ross and other members felt sympathy for the occupant of Mallard Cottage. Councillor Notton felt that before giving an opinion on the diversion, the whole of the pathway should be shown. The Town Mayor - Councillor Gray felt that the safety of the children should be considered. Proposed by Councillor C. M. Green, seconded by Councillor Mrs.O.L.Delyle-Turner that -

In principle this Council accepts the proposed route from A.C.D. to E. with suitable amendments between points A - C ie that twice as much as the 1.8 metres stated, should be taken for the path so that sympathetic treatment can be taken ie the planting of hawthorn each side of the path to provide a suitable hedge which would cut down on noise and convey more light. It is also suggested that street lighting be installed, particularly at point C.

The RESOLUTION was carried by 6 votes in favour and 5 against.
