Comments were made on the lack of community facility on this estate together with the absence of garages and the increase in units.

There was also strong feeling that covenants should be attached to the dwellings so that they remin low-cost in years to come.

RESOLVED:

That the Marlborough Town Council objects to this planning application on the following grounds -

lack of garages - it is felt that it is much less costly, and neater, to erect garages at the same time as the dwellings

lack of chimneys - required for strength, ventilation and moderately priced fuel

no provision for a play area

no provision for a Village or Community Hall - with the increase in density there is a social obligation for the provision of such

it is felt that one of the larger dwellings should be reserved for 'multiple use' ie shop or public house etc.

lack of provision for post boxes and telephone kiosks

we share the concern of the Civic Society on there being only one entrance to the estate, and would like to see some form of traffic control on entering the estate ie sleeping policeman

lack of provision for grit bins in appropriate places

This Council would also like to be consulted on the naming of this estate.
