The situation is currently under investigation by the Council's Enforcement Section but I can confirm that listed building consent has not been sought or granted for these works, to date. I agree that the colour scheme that has been introduced is particularly strident and, following talks with the owners' agents, I am hoping agreement will be reached on repainting in a more subtle colour scheme.

An application for listed building consent would only be required if the works were to constitute an alteration to the character of the building and, were a scheme to be agreed that constituted only a subtle alteration to the original situation, it would possibly not require consent. However, I anticipate that an application will be forthcoming in this case and, once received, the Town Council will obviously be consulted.
